

Adult Model Release

From today forward, for full and adequate consideration, I, being of lawful age, do grant full authority and permission to Mark & Christine Warye, a.k.a. Naughty or Nice Photography (hereinafter, the "Photographer"), the Photographer's representatives, assigns and successors-in-interest, and all other persons, firms and corporations who the Photographer authorizes, to copyright and use any and all types of still or video graphic photography, or images made by any other device or means by which images can be recorded, stored, projected, transmitted, displayed, or played back, including, but not limited to, negatives, prints, CD-ROM's, tapes, illustrations, portraits, designs, paintings, drawings, video graphs and the like (hereinafter, collectively, the "Photographs"), taken of myself by the Photographer, as the Photographer sees fit, including, but not limited to, publishing, exhibiting, displaying, printing, advertising, promotional displays, magazines, books and other types of media, or for any other legal purpose.

I understand and agree that the Photographs are the sole property of the Photographer and that he may assign this property at his sole discretion and to whom and in whatever manner he wishes totally without interference from me. I also hereby waive any right to inspect, approve, or otherwise control the Photographs prior to sale or use, whatever that use may be.

Furthermore, I hereby forever release, acquit and discharge the Photographer and his representatives, assigns and successors-in-interest, and all other persons, firms and corporations who the Photographer authorizes, from actions, causes of action, claims, demands, damages, costs, loss of service, loss of use, expenses and compensation, on account of, or in any other way growing out of, any and all known and unknown uses of or conduct associated with the Photographs.

It is understood and agreed that by my signature below, the terms of this Agreement and Release of All Claims are contractual and not a mere recital, and that further, this Agreement and Release of All Claims contains the ENTIRE AGREEMENT between the parties hereto, even should this agreement differ with prior discussions between myself and the Photographer or with any agreements made by the Photographer with other individuals in similar circumstances.

I further state that I have carefully read the foregoing Agreement and Release of All Claims and know the contents thereof, and have satisfied myself as to its terms. I further state that, in making this Agreement and Release of All Claims, I rely wholly upon my own judgment, belief and knowledge, or those of trusted advisors, and that I have not been influenced to any extent whatsoever, or in any way, by the Photographer, his representatives, assigns and successors-in-interest, or any and all other persons, firms and corporations who the Photographer authorizes or are associated with him in any way.

I further affirm that I am of legal age to enter into this Agreement and Release of All Claims, and that I have shown proof of my legal age by showing to the Photographer the following items, at least one of which is issued by a Federal or State Agency, to wit:
